

PREDATOR PAINTBALL - WAIVER, RELEASE AND INDEMNIFICATION FORM

THIS IS A LEGAL DOCUMENT – PLEASE PRINT CLEARLY

To Predator Paintball, I hereby acknowledge that:

1. I am aware that my use of the Company's equipment, services facilities, playing paintball and in particular my use of paintball guns and associated equipment carries additional dangers and risks of injury and I agree to accept all such dangers and risks.
2. I agree to assume all risks arising out of my use of equipment, services and facilities provided to me by the Company.
3. I agree for myself, my executors, administrators, heirs, next of kin, successors and assigns to release the Company from any and all liability no matter how it arises in respect of any injury, loss or damage suffered as a result of my use of the Company's equipment, services and facilities.
4. I agree for myself, my executors, administrators, heirs, next of kin, successors and assigns to indemnify the Company in respect of any liability it may have to any third party, which in any way arises from my use or my attempted use of any of the Company's equipment, services and facilities.
5. I agree to abide by the safety instructions, rules and suggestions established by the Company regarding the use of its equipment, services and facilities at all times, and I understand that my failure to follow such safety instructions and rules will warrant my removal from the property.
6. I agree to undertake at all times to wear and not remove, unless instructed to do so by the Company, my protective headgear whilst on or near the designated playing area.
7. I accept full responsibility for all equipment supplied to me and agree to cover the full cost of any equipment that maybe lost or damaged whilst in my care. I understand that if I do not return my player card I will be liable to pay all charges on it.
8. I am over the age of sixteen (16) years.
9. I am not under the influence of alcohol, drugs or other controlling substances.
10. Employees, servants or agents of the Company have no authority to accept goods or articles for safe custody from any person. The Company shall not be responsible for such loss or damage (no matter how or why it occurs) to any such goods left at the premises of the Company.
11. No agent, servant or representative of the Company has authority to alter modify or waive any of the above conditions.
12. Whenever the word "Company" or "Company's" is referred to in these conditions, it shall mean Adrenalin Games Pty Limited trading as Predator Paintball, and shall include all employees, agents, servants and representatives thereof.
